



Rockville Sister City Corporation Corporate Sponsorship Program

The City Rockville, Maryland and the City of Pinneberg, Germany became Sister Cities in 1957. Rockville formed a Friendship City relationship with Jiaxing, China in 2009. Rockville Sister City Corporation (RSCC) was established in 1986, as a 501(c)(3) nonprofit organization that seeks your support to help us achieve our mission of peace and international cooperation through the active facilitation of the Sister City relationship between the cities of Rockville, Maryland and Pinneberg, Germany as well as a Friendship City relationship between the cities of Rockville, Maryland and Jiaxing, China.

RSCC has a tiered fundraising approach to accept donations from supporting organizations, with “Gold,” “Silver,” and “Bronze” sponsorship levels.
