Dwight Eisenhower in 1956 to promote world peace.

PRESIDENT'S MESSAGE

The first part of 2018 has been a very exciting time for the Rockville Sister City Corporation. There have been many new developments as we move forward in the furtherance of RSCC's mission of peace and mutual understanding in the maintenance and facilitation of Rockville's Sister and Friendship City relationships.

Recently, longstanding RSCC Board members, **Wayne Savage** and **Gerrie Checkon**, stepped down from the RSCC Board as they have moved from the Rockville area. We wish Gerrie, Wayne and their families well as they pursue their aspirations in retirement. New RSCC Board members were appointed and unanimously approved by the Rockville Sister City Corporation Board of Directors at the May 15, 2018 RSCC Board meeting. **Kent Wong** and **Kuan Lee** will serve out Wayne and Gerrie's terms until the next Annual RSCC General Membership Meeting, which will be held at Rockville City Hall in the Mayor and Council Chambers on Thursday, September 13, 2018.

I am also pleased to announce that Rockville's Jiaxing Friendship City relationship is moving forward with several planned activities, which have included a well-attended "Event Showcasing Jiaxing, China" at the Seven Seas restaurant on May 3, 2018 and future cultural exchanges scheduled for this year. As Jiaxing and Rockville move toward our tenth anniversary as Friendship Cities in 2019, efforts are currently underway to explore a Rockville-Jiaxing Sister City relationship. RSCC Board members, Ying Chen and Bing Huang have worked diligently towards the goal of strengthening the two cities' relationship and now serve as co-chairs on a formally recognized RSCC Jiaxing Committee, whose responsibilities include preparations for tenth anniversary activities, including the exchange of Jiaxing and Rockville delegations in 2019.

The Rockville Sister City Corporation Board of Directors formally recognized a Yilan Committee, as we explore a potential Rockville Sister City relationship with Yilan, Taiwan. As part of this process, the RSCC Board of Directors reviewed and approved a detailed Yilan proposal, conducted a successful Meet and Greet with the Rockville Yilan City Corporation (RYCC) and is now looking to next steps, which include reciprocal cultural exchanges between our two cities. In addition to these activities, the RYCC held the first annual "Bubble Tea Festival" in Rockville Town Square on Sunday, May 20, 2018. The event was host to nearly a thousand attendees and featured presentations of Taiwanese culture and cuisine.

The Rockville Sister City Corporation also participated in the enormously successful "Peerless Rockville Historic Homes Event," where RSCC Board members, general members and friends of RSCC helped to present one of Rockville's historic homes. RSCC Director, **Bob Wright**, was instrumental in organizing this effort.

As part of RSCC's newly designated scholarship program, the Rockville Sister City Corporation took part in the Richard Montgomery High School Annual "Student Awards Ceremony," which was held on May 16, 2018. Participating students created brochures, which promoted the City of Rockville. Stipends of \$1,000, \$750 and \$500 were awarded to first, second and third prize entries respectively. Many thanks to RSCC Director, **Christian Jessen-Klingenberg**, for making the first Annual RSCC Prize Competition a great success.

Lastly, the Rockville Sister City Corporation wishes to thank **George Albrecht**, who announced that he is stepping down as RSCC webmaster. George did a great job with the RSCC website over the years and will be missed.

Looking forward, 2018 promises to be a great year for Rockville's Sister City program with RSCC's participation in Rockville's Hometown Holidays and Memorial Day Parade, June Membership Appreciation/Mayor and Council Meet and Greet event, August Dim Sum, RSCC Annual Meeting in September and Rocktobierfest, German American Day Dinner and World of Montgomery in October. We hope you are part of the fun! ■
